

The following refuse and items are to be returned

Return to points of sale



Retailers are obliged to take back **PET drinking bottles, aluminium beverage cans, rechargeable and non-rechargeable batteries**, solvents as well as all kinds of electronic electric appliances. Shops are only obliged to take back these items if they sell goods of the category concerned. You can take these items to a shop whether you bought them there or not and you are not obliged to buy anything new there.

Collection points for hazardous waste



Several pharmacies/chemists or specialist shops and recycling parks accept **hazardous waste** in small quantities free of charge. Locations in your vicinity and information about maximum quantities can be found on the refuse collection plan or on the internet at: www.aue.bs.ch/a-z.

Clothing, shoes, textiles



Clothing, shoes and textiles are regularly collected by private collection organizations. For this, use the bags that you will find in your letter box in advance. The necessary information and the date of collection are printed on the bags. You also have the possibility of using clothing containers. You will find their locations at: www.aue.bs.ch/a-z.

Refuse disposal in Basel

Refuse disposal in Basel

A warm welcome to Basel!

This leaflet will give you an overview of how refuse disposal functions in Basel.

Sooner or later every consumer product becomes waste material. Responsible behaviour can help us try to avoid waste. It is clear: Refuse which does not come into existence cannot burden the environment. Waste cannot always be avoided. In this case, local recycling is best or, as a final option, refuse can be disposed of in a way compatible with the environment.

The polluter pays principle, which applies to the whole of Switzerland, creates an incentive for careful handling of our resources. The consumer who produces waste is expected to pay the costs of recycling or disposal in an environmentally compatible way. Either the consumer pays the recycling costs with an advance disposal fee when purchasing the product, or pays directly for the disposal, as is the case with the Basel rubbish bag, the so-called "Bebbi-Sack".

We would like to help you prepare your refuse and recyclable material, and show you where it can be disposed of. With the right disposal, you can do your bit to maintain a city that is worth living in, and to help keep costs for refuse disposal and waste collection fees low.

The following refuse is collected

Refuse collection plan

Each year every household receives a refuse collection plan, which is also given to newcomers. It contains the collection dates for the various kinds of waste and recyclable materials. The refuse collection plan also contains information about how the refuse must be readied for collection.

Household rubbish



Household rubbish in Basel may only be deposited in the official light-blue Bebbi sacks, in containers which are only for the collection of Bebbi sacks, or in special containers, which charge according to the weight of the refuse (WIGA containers).

Bebbi sacks can be obtained from retailers over the counter in rolls of ten bags each and in three sizes (17, 35 and 60 litres). No more than 20 kg of waste may be disposed of per bag.

Paper/cardboard



Paper and cardboard must be bundled with string separately. Please do not use adhesive tape or carrier bags.

Valid for household rubbish, bulky trash, non-inflammable waste materials, paper, cardboard and compost: In every case deposit the rubbish after 19:00 the evening before, or at the latest before 7:00 on collection day, whatever the weather, clearly visible at the roadside. Depositing rubbish at other times is subject to a fine of CHF 50.00.

Bulky goods



Bulky goods, non-inflammable rubbish and compost must be provided with an adequate number of fee vignettes and deposited clearly visible at the roadside. For some of these items to be collected they have to be registered via our cleanliness hotline or the internet. Details can be found on the refuse collection plan.

If the refuse has not been registered or if the refuse deposited contains foreign matter (for example, Styrofoam in compost), it will not be collected. If there are not enough fee vignettes, the refuse is considered as illegal dumping, and it will not be collected.

Fee vignettes

Bulky goods vignettes

For the disposal of bulky goods and non-inflammable refuse (ceramic, stone, clay, etc.) fee vignettes are necessary; you can obtain them over the counter at a retailer's. The refuse collection plan contains a list of sales outlets. For each 10 kg of refuse a vignette for CHF 4.50 is required.

Free bulky goods vignettes

The refuse collection plan contains two free bulky goods vignettes per year.

Compost vignettes

For the collection of compost, compost vignettes are necessary; you can get them over the counter at a retailer's. You can determine the amount needed from the refuse collection plan. It also contains a list of points of sale.

Vegetation refuse

Organic kitchen waste



Composting in your own garden, backyard or on the balcony is actively encouraged by the city. The compost consulting service places advice and material at your disposal free of charge. The compost consulting service also supplies information about the use and locations of neighbourhood composting centres.

Compost consulting service and composting courses

The compost consulting service shows you how to make compost on site, in your backyard, on your balcony or in your garden. It also places material and tools at your disposal free of charge.

Chaff cutting service

Tree and shrub cuttings can be shredded on site and then composted. 1 m³ is free per house entrance. The dates of the cutting service and information on booking are in the refuse collection plan.

Garden refuse, tree and shrub cuttings, balcony plants



Vegetation refuse constitutes valuable structural material for the compost in your own garden or backyard. Use the chaff cutting service for this. If this isn't possible, dispose of your vegetation refuse for a charge with the vegetation collection service.

Recycling

Recycling stations



In Basel there are around 50 recycling stations where you can dispose of bottle glass, aluminium, tin, batteries and rechargeable batteries from 7:00 to 20:00 Monday to Saturday free of charge.

Recycling parks

In the recycling parks you can conveniently dispose of most refuse and recyclable materials in one place. Certain refuse is subject to a charge.
